ABOUT THIS PRODUCT

Recommended Uses: This product is intended for use as both an initial seal and subsequent finish coat on, warehouse, factory, garage or other institutional and industrial concrete floors. Apply a minimum of 2 coats of this product.

DIRECTIONS

Recoating previously finished floors: Clean floors by damp mopping or wet scrubbing and allow to dry. To abrade the floor use a stiff brisstle brush with a scrubber or buffer to remove soils, contamination and black marks. If using a rotary floor machine overlapping 1 to 2". Tack or rinse the floor with clear water to remove dust residues. Apply finish with applicator or roller. In using a single pass applicator, give special attention to moving at a slow walk and run 1" to 2" puddle in front of the applicator head, overlapping each pass approximately 5" angling the applicator head to allow excess finish to tail off the side toward the unfinished floor where the excess can be further leveled on the next pass.

PRECAUTIONARY STATEMENTS

Prevention: Keep away from heat/sparks/open flames/ hot surfaces. No smoking. Keep container tightly closed. Ground/bond container and receiving equipment. Use explosion-proof electrical/ ventilating/ lighting/ equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Wear protective gloves/ eye protection/ face protection. Wash hands and exposed skin thoroughly after handling. Obtain special instruction before use. Do not handle until all safety precautions have been read and understood. Avoid breathing dust/fume/gas/mist/vapors/spray. Use only outdoors or in a well-ventilated area. Response: IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water/shower. In case of fire: Use dry sand, dry chemical or alcohol-resistant foam for extinction. Specific treatment: see section 4 on the Safety Data Sheet. If skin irritation occurs: Get medical advice/attention. Take off contaminated clothing and wash it before reuse.
