### ABOUT THIS PRODUCT

Re-Claim Whites is a powdered detergent additive designed to restore linen that has been discolored by soils and stains. Leaves fabric clean and bright. For institutional laundry use only. Do not use in home style washers.

### DIRECTIONS

1. Fill washer to capacity with linen.
2. Start machine and allow it to fill with hot water to low level.
3. Add 1 jar of Re-Claim Whites per 50 pounds of dry linen.
4. Wash for 12 minutes.
5. Drain.
6. Run linen through a minimum of 3 rinses (1-hot and 2-warm water).
7. Extract
8. Dry in Dryer

### PRECAUTIONARY STATEMENTS

**Prevention:** Keep away from heat. Keep/Store away from clothing and combustible materials. Take any precautions to avoid mixing with combustibles. Wash hands and exposed skin thoroughly after handling. Do not eat, drink, or smoke when using this product. Do not breathe dust or mists.
