SYNTHETIC DYE STAIN REMOVER

ABOUT THIS PRODUCT

Red Out is a one part product specifically formulated to remove synthetic stains from carpets. Do not use for organic stains such as pet urine, food or vomit etc.

DIRECTIONS

SHAKE WELL BEFORE USING.

1. Check stain to make sure it is dry. If not blot dry with a clean towel.
2. Apply Red Out directly from the bottle to the stained area. Allow to soak for a few seconds before starting. Next lay a moist, 100% cotton white towel or wash cloth over stained area.

3. Fill your normal household steam iron with plain tap water. Set iron at lowest heating setting (that will produce steam).

NOTE: Higher heat does not speed up the process- It slows the process down and sets the stain.

4. Set the preheated iron on top of the towel directly over the stained area. Do not apply pressure. Use the weight of the iron only.

5. Allow iron to set on towel until it starts to boil around the edges. This should take approximately 20-40 seconds.

6. When boiling starts apply pressure to handle of iron and hold firmly on towel for about 10 secons, then lift iron and towel, check for transfer, shift iron to clean moist area on towel and repeat if necessary. TEST all products in an inconspicuous area for desired results prior to using. DO NOT use on delicate fabric or Persian rugs.

PRECAUTIONARY STATEMENTS

Prevention: Keep away from heat/sparks/open flames/ hot surfaces. No smoking. Keep container tightly closed. Ground/bond container and receiving equipment. Use explosion-proof electrical/ ventilating/ lighting/ equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Wear protective gloves/eye protection/face protection. Wash hands and exposed skin thoroughly after handling.

Response: IF ON SKIN (or hair): Take off immediately all contaminated clothing. Wash with plenty soap and water. In case of fire: Use dry sand, dry chemical or alcohol-resistant foam for extinction. Call a POISON CENTER/doctor/medical professional if you feel unwell. Specific treatment: See section 4 on the Safety Data Sheet). If skin irritation occurs, get medical advice/attention. Take off contaminated clothing and wash it before reuse. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. IF SWALLOWED: Immediately call a POISON CENTER/doctor/ medical professional. Do NOT Induce vomiting. **Storage:** Store in a well-ventilated place. Keep cool. Store locked up. **Disposal:** Dispose of contents/container in accordance with local/ regional/ national/ international regulations.
